## NOTE:

- Bidder to mandatorily provide detailed BOQ (in the form of annexure) as per the finalized architecture that is being proposed to be deployed.
- The bidder shall provide 7 years of onsite warranty after user acceptance of all supplied, installed, configured and commissioned system including hardware and software. Any software updates, upgrades, patches released till the completion of warranty period shall be supplied, installed and commissioned under scope of agreement / PO / RC. Training to TPCODL employees on new version of software from the OEM or OEM's certified training partner shall be arranged by the bidder. Bidder shall maintain the Hardware and software on 24X7 basis during Warranty period as per agreed SLA.
- Facility Management Services Charges (as mentioned above) shall not be less than 20% of the overall tender BOQ.
- The integration cost at S. No. 3 above shall be with consideration all inclusions as per Scope of Work at Annexure VII.
- Optimum hardware sizing should be done by the bidder taking into consideration the details as mentioned in technical specification and use schedule to enter the details in the BOQ for hardware & other items. The analysis to arrive at hardware sizing and detailed hardware specification of equipment (eg: Number of CPUs, memory, disk, disk size) be shared with TPCODL. It should be noted that, if during commissioning it is identified that any additional hardware / software is required for running the system, it would be on bidders cost only. (Hardware of Dell, IBM, HP or CISCO only should be considered for designing of system). Vendor has to provide desired performance with supplied hardware.
- Bidder should take provision of development, Test and Quality servers in addition to production server.
- The unit price to be indicated in col. No. 6 should be exclusive of taxes & duties which are to be indicated in separate columns meant for the purpose.
- The prices shall be FOR TPCODL Locations.
- Prices shall be firm till the validity of contract.
- The bids will be evaluated commercially on the overall lowest cost basis.
- The unit price with GST in column no. 7, is landed price for TPCODL.
- The bidders are advised to quote prices strictly in the above format. Failing to do so, bids are liable for rejection.
- The bidder must fill each and every column of the above format. Mentioning "extra/inclusive" in any of the column may lead for rejection of the price bid.

- No cutting/ overwriting in the prices is permissible.
- The bidders shall quote against each of the line items as indicated above. The quantity as mentioned above neither implies nor guarantees any minimum deployment thereunder. The above quantity is indicative only based on TPCODL estimates and it is not binding on us for fulfillment. Actual quantities may vary as per TPCODL's requirements.
- The rates quoted under **2c (incremental at the rate of 50000 end points)** shall be valid for 7 years and TPCODL reserves the right to order any quantity as per their business requirements.
- DR will be deployed at a later stage. OEM has to provide all details of DR up front along with entire architecture, design and hardware required to install it considering as if it will be deployed along with DC. Its cost shall be valid for three years from the date of placement of order and will be considered for price bid evaluation. Only network connectivity and space will be provided by TPCODL for installation of DR, everything else will be in scope of bidder.
